

Trends of Marijuana Legalization and Use

Marijuana legalization and use is clearly on an upward trend. While its status has changed drastically over the past century, marijuana is now widely accepted as a medicinal and recreational substance.

For example, cannabis was widely used for medicinal and recreational purposes in the early 1900s, but numerous states began enacting anti-marijuana laws around this time. By 1937, marijuana was illegal in every state except for medical use.

In the 1960s, marijuana was widely associated with the counterculture movement and began to gain a foothold in popular culture. This led to increased criticism of marijuana laws, leading President Nixon to declare a war on drugs in 1971 and pass the Controlled Substances Act (CSA). The CSA placed cannabis as a Schedule I drug, meaning that it was considered to have no medical value and a high potential for abuse.

In the 1990s, various states began relaxing their marijuana laws, allowing for the medical use of cannabis. In 1996, California became the first state to legalize the medical use of marijuana, followed by Alaska in 1998. By the mid-2000s, several other states had either legalized or decriminalized the possession of marijuana for personal use, mainly because Cannabinoids in marijuana have been linked to several therapeutic benefits, including pain relief, nausea reduction, reduction in inflammation, and improved sleep quality. Studies have also found that cannabis can help with anxiety, depression, and even reduce the symptoms of PTSD.

In 2012, Colorado and Washington became the first two states to legalize recreational marijuana. Since then, more than a dozen other states have followed suit. In 2018, Canada became the second nation in the world to legalize recreational cannabis. The legalization of marijuana has clearly allowed for the creation of a legal cannabis industry that has and continues to expand. Consequently, as the marijuana industry expands, so does the need for effective odor abatement solutions. Even with potential medical benefits and more legalized use, marijuana still retains its often, skunky smell.

What causes Marijuana to Smell





The smell of marijuana is created by organic compounds found in the essential oils of plants. The cause of this smell can be attributed mainly to the **terpenes** found in cannabis plants, which are aromatic compounds that give the marijuana its unique scent. Terpenes interact with other chemicals in the plant and can produce an array of smells from floral, fruity, skunky, earthy, and even diesel-like aromas.




The smell of marijuana is also affected by the growing environment and curing process, with each strain producing its own unique scent. All this combines to make a **strong odor** that can be quite pungent and pervasive when smoked or vaporized. The burning or vaporizing of marijuana can produce additional pungent aromas due to the combustion process. Depending on the strain, this can make it smell even more intense and unpleasant.

In specific, **Prenylthiol**, otherwise known as 3-methyl-2-butene-1-thiol, is an organic sulfur compound found in many plants and herbs, including marijuana. Research shows that Prenylthiol is responsible for much of the distinctive smell associated with marijuana and other cannabis products. It has a strong pungent odor that gives marijuana its skunky and earthy smell.

More interestingly, Prenylthiol's molecular formula is C5H10S, meaning it is comprised of 5 carbon atoms, 10 hydrogen atoms, and one sulfur atom. Notably, sulfur is only stinky when it is in certain compounds such as Prenylthiol.

We'll come back to Prenylthiol later as it is important. But don't worry, we'll review the information for you!



How Can the Smell of Marijuana Be Abated?

Several methods have been proposed and used to try to abate the pungent smell of marijuana.



Clearly, there are ways to try to abate the pungent smell of marijuana, but current solutions are either not cost-effective or only mask smells rather than neutralize or even change the smell.

Some popular methods include the following:

- Mechanical ventilation involves the use of fans and ducting to capture and exhaust odors. The size, layout, and location of fans and ducts must be carefully engineered to ensure maximum odor control.
- Another popular solution for controlling marijuana odors is air scrubbing. Air scrubbers are devices that utilize various filtration media to catch odors and other particles from the air. They can be used in conjunction with mechanical ventilation systems for more effective odor control.
- The problem with these methods is that they are rather costly.

Some natural methods include the following:

- Essential oils, such as lemongrass, lavender, and peppermint can reduce odors.
- Candles can also be lit with specially designed fragrances to create pleasant aromas and mask the smell of cannabis.
- The problem with these methods is that they just mask the unpleasant marijuana odor, often creating competing smells in the environment. In essence, they are not very effective in that they only mask, but do not neutralize or even change the smell.

An effective solution would be to not just neutralize or mask but change the unwanted smell. This is not what current on-the-market solutions are able to do. Fortunately, we problemsolved the issue for you and came up with a solution!



Marijuana can smell skunky because of a chemical molecule called Prenylthiol, which is comprised of 5 carbon, 10 hydrogen, and 1 sulfur atom. The sulfur is what stinks when it is in a compound combination like Prenylthiol.


